Note: Persons are advised that if they wish to appeal any decision made at any meeting, they will need a record of the proceedings, and for such purpose they may need to ensure that a verbatim record of the proceedings is made, which record includes the testimony and evidence upon which the appeal is to be based per Section 286.0105, Florida Statutes.
